

# 1 Million EZ Points Giveaway Sweepstakes Official Rules

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

## 1. Eligibility

1 Million EZ Points Giveaway Sweepstakes (the “Contest”) is open only to legal residents of Alabama, Arkansas, Arizona, Colorado, Florida, Georgia, Iowa, Illinois, Indiana, Minnesota, Mississippi, Nevada, Oklahoma, Oregon, Pennsylvania, Tennessee, Texas, and Utah, who are at least eighteen (18) years old (19 years old in Alabama) at the time of entry. Void where prohibited by law. Once a profile has been created, the User must click “enter to win” button in EZ+ App. One (1) entry per EZ+ account per day. All entries become the sole and exclusive property of Sponsor. ## 5. Alternate Method of Entry

## 6. Winner Selection

Within 1 business day after the end of the entry period, Sponsor will conduct a random drawing, selecting two hundred winners amongst eligible entries. Each time the Sponsor conducts a random drawing it is committed to awarding 5,000 EZ Points, with an estimated value of approximately \$50. The selected entrants will be contacted using the email address and/or phone number associated with their EZ+ online account and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Sponsor’s decisions as to the administration and operation of the Contest and the selection of potential winners are final and binding in all matters related to the Contest. Winners will be notified by December 17, 2025. If attempts to contact a winner are not successful or the winner does not respond within three business days, the winner forfeits the prize and an alternate winner will be selected. Sponsor is not responsible for incorrect email addresses or phone numbers provided by potential winners. In the event that a potential winner of a prize is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.

**9. Prizes**

There will be two hundred (200) winners selected. The winners will receive 5,000 EZ Points each, with an estimated value of approximately \$50 for a total of one million EZ Points awarded. Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Winner is responsible for all taxes associated with prize receipt.

**10. Entry Conditions and Release**
