

## EZ+ Fridays “Spin to Win” Sweepstakes Official Rules

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

### 1. Eligibility

EZ+ Fridays “Spin to Win” Sweepstakes (the “Contest”) is open to customers<sup>1</sup> who are at least eighteen (18) years old at the time of entry. Void where prohibited by law. Employees of Sponsor, as defined below or any of its respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Contest and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such employee are not eligible. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Contest. ### 2. Sponsor

### 3. Contest Period

Each Friday of the Contest Period, starting at 12:00:01 a.m. PST through 11:59:59 p.m. PST, a person may access the EZ+ app at [app.ezplus.com](http://app.ezplus.com) to spin a wheel. Sponsor is the official timekeeper for this Contest.

### 4. How to Enter

To enter the contest, a person must have an EZ+ app account. During the Contest Period, visit [app.ezplus.com](http://app.ezplus.com) and follow the prompts provided to spin the wheel in the EZ+ Friday Spin to Win game. Limit one (1) spin per person each Friday of the Contest Period. All entries become the sole and exclusive property of Sponsor. See Subsection 10, Prizes below for information on Contest prizes and odds of winning.

### 5. Alternate Method of Entry

### 6. Winner Selection

The Spin to Win potential winners will be notified immediately at the conclusion of their entry play in the EZ+ app. See Subsection 10, Prizes below for information on prizes and odds of winning. Any EZ+ Rewards points won on Friday of the Contest Period expire at 11:59:59 p.m. PST on the Thursday following the Friday spin on which the prize was awarded, except as otherwise noted in Subsection 10.

<sup>1</sup> Only customers are eligible to participate in the Sweepstakes. Customers are individuals with an EZ+ app account, and do not include companies or wholesalers. Customers must be at least eighteen (18) years old at the time of entry.

**7. POTENTIAL CONTEST WINNER IS SUBJECT TO VERIFICATION BY SPONSOR WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.**

**8. Verification of Potential Winner**

As a requirement of winning, the potential winner must continue to comply with all terms and conditions of these Official Rules and [EZ+ Rewards Terms & Conditions](#). Failure to comply with all terms may result in winner's forfeit of prize.

**9. Winner Acceptance**

By accepting the prize, the winner agrees to allow the Sponsor and its designees to use the winner's name, likeness, photograph, voice, biographical information, and/or statements for advertising, promotional, and other purposes in any media now known or hereafter developed, worldwide and in perpetuity, without additional compensation, notification, or permission, except where prohibited by law.

**10. Prizes**

Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. For prizes with an estimated value over \$600, Sponsor will issue an IRS 1099-MISC in compliance with IRS regulations. Winner is responsible for all taxes associated with prize receipt and may be required to complete an IRS W-9 Form. The Spin to Win prizes (and chances of winning with each spin) are as follows\*:

- 500 EZ+ Reward Points (40% chance of winning)
- 5X EZ+ Reward Points on next purchase (24% chance of winning)\*\*

The resulting multiple points of 5X or 7X after a qualifying purchase are considered Bonus Points and expire at the end of month after ninety (90) days of receipt of Bonus Points. **11. Entry Conditions and Release**

Contest, and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Sponsor from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Contest and/or entrant's acceptance, use or misuse of prize.

## **12. General Conditions**

Sponsor reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Sponsor in its sole discretion. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

## **13. Limitations of Liability**

The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error which may occur in the administration of the Contest or the processing of Entries; or (e) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use or misuse of any prize. If for any reason an entrant's Entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another Entry in the Contest. awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.
